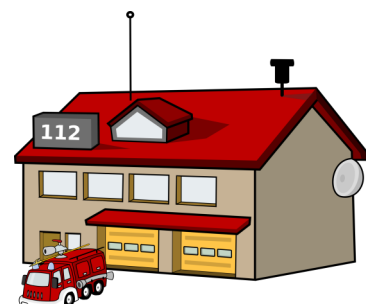

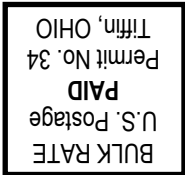

## Helpful Tips to Recycling Properly at the Aim to be Green Township Recycling Drop-off Sites

The Aim to be Green Township Recycling Drop-off Program operates successfully throughout Ottawa, Sandusky and Seneca Counties. The program which began October 1, 2012 provides service to 178 eight-yard recycling bins located at 41 sites. Materials accepted for recycling include the following household items: aerosol cans (tip removed), aluminum cans, cardboard, glass bottles/jars, cartons, magazines, newspaper, office pa-



per / junk mail, paperboard, #1 and #2 plastic bottles, #3 through #7 plastic food containers and steel cans.

To help maintain a successful program look at the following reminders to make your next recycling experience quick, easy and contamination free.

- Recycling bins are available 7 days a week during daylight hours.
- Place materials in the recycle bins all together (mixed or unsorted).
- If recycle bins are full of material: **Please DO NOT place recyclable materials on the ground next to the bin.**
- Plastic bags should not be placed into the recycle bins.
- Do not include contaminated materials or items soiled with debris or food residue.
- It is important to break down all cardboard / paperboard boxes to conserve space in the recycle bins.
- Do not place polystyrene (e.g. – Styrofoam), packaging materials or plastic bags into the recycle bins.
- All #1 and #2 plastic bottles and food containers numbered #3, #4, #5, #6 and #7 are accepted. The number can be found at the bottom of the plastic bottle or container inside a recycle

symbol.

- Be sure to close the lids on top of the recycle bin or the sliding doors on either side of the bin after use to prevent loose materials from blowing out of the bin.
- If you see loose materials on the ground next to the recycle bins, please help keep the area clean by picking up the materials and placing them into the recycle bin.
- Some containers have lid locks to prevent the lids from blowing open during windy conditions. In this case, it is best to use the small openings or the sliding doors.

## Spring Building Permits and Zoning

Remember to call and get Building Permits for these items this spring:

- ◆ Pools & Decks
- ◆ Pole Buildings
- ◆ Fences
- ◆ Garages & Sheds
- ◆ Home Additions
- ◆ Propane Tanks

Do I need a permit if I purchase a pre-built structure?

Yes, even pre-built structures need a building permit before being installed. These sheds and playhouses are becoming very popular, and usually come in on a skid and they

are required to abide by zoning regulations.

Do I need a permit for a temporary pool?

No, if you are putting up a seasonal pool, meaning it will come down in the fall, then no permit is needed. It will still need to abide by the property line setbacks though.

How long does it take to get a permit?

Usually permits are granted at the same time you make the application and pay the fee. Only if there is a problem with the plans would the permit be delayed.
