

Clinton Township Board of Trustees – Regular Meeting
March 5, 2018 – 7:00 p.m.

All Board members answered roll call – Trustee Dennis Moyer, Trustee James Distel, Trustee Dennis Baugher, and Fiscal Officer Jennifer Bates.

Guests: Fred Bishop, Eric Bishop, Frank Laney, Diana Warnement, Phyllis Watts, and Dennis Kingseed.

The minutes of the meeting held February 19, 2018 were read and approved.

Correspondence: Seneca County Prosecutor's office – memo regarding the hiring of Richard Palau

Fire Chief Fred Bishop reports that the fire department voted to recommend that Eric Elchert and Connor Haner be added to the volunteer fire department. Eric Elchert already has is 36 hour card. Trustee Baugher made a motion to hire Eric Elchert and Conner Haner to the Clinton Township Volunteer Fire Department, seconded by Trustee Distel. Mr. Moyer – yes, Mr. Distel – yes, Mr. Baugher – yes.

Chief Bishop also reports that the Seneca County Firefighters Association is doing a fundraiser at Buffalo Wild Wings in Tiffin on Saturday, March 10th from 11:00 am to 5:00 pm to raise money for smoke detectors to be handed out. They will be having a 50/50 drawing and raffle.

Zoning Inspector Frank Laney reports that he has issued 2 permit since the last meeting. Trustee Baugher asks what is the zoning of the property on CR 50 that is up for auction. It is zoned A-5 Agricultural and the splits have not yet been approved.

Regarding the next newsletter, Trustee Moyer has some information that could be used. Zoning Inspector Laney is shooting to get it mailed out in April.

Trustee Baugher reports that he spoke to AEP and got a contact name regarding moving the power poles on CR 50. He has passed the information on to resident Gary Hohman.

Trustee Baugher also reports that he and Chief Bishop met with Jim Keller regarding the tanker truck. They hope to get it in for repairs this week.

Trustee Distel reports that the COG annual meeting has been changed from March 23rd to April 6th. It is still at 8:30 am. He also obtained information about free Grant Writing Assistance being offered by the Tiffin Community Foundation.

Trustee Moyer reports that he spoke to Mark Liebrecht about moving some ditches back. He would like to do it in late May or June and he will put us on the list.

Trustee Moyer also says Jim Lang received a call wanting to know when the barricades on TR 177 will come down.

Trustee Baugher asks Fiscal Officer Bates about the new Police & Fire Grant. She does not have any information about it. Trustee Baugher says we can get the application online and see what it says. Chief Bishop thinks it only applies to services that are already in place.

Trustee Moyer asks when Conner Haner will be able to take his training. Chief Bishop says there is a volunteer class in April and he can take the transition class right after that.
