

Clinton Township Board of Trustees – Regular Meeting
May 29, 2018 – 7:00 p.m.

All Board members answered roll call – Trustee Dennis Moyer, Trustee James Distel, Trustee Dennis Baugher, and Fiscal Officer Jennifer Bates.

Guests: Fred Bishop, Eric Bishop, Frank Laney, Diana Warnement, Phyllis Watts, Dennis Kingseed, and Scipio Township Trustee Dale Laibe.

The minutes of the meeting held May 14, 2018 were read and approved.

Correspondence: OSS Solid Waste District- email regarding grant meeting

Scipio Township Trustee Dale Laibe asks if the Board set up a meeting with Kris Hopkins from CT Consultants regarding the Seneca County Comprehensive Plan. Trustee Distel says he is meeting with them tomorrow, May 30th. They are trying to meet with one person from each entity to get their input.

Trustee Laibe also says our road worker Jim Lang called him about getting a quote for tilling on TR 159. He looked but could not find where he was talking about. Trustee Baugher says it is south of SR 18. Trustee Laibe will go look at it and get back to us.

Zoning Inspector Frank Laney reports that he issued three permits since the last meeting. He also says that the Zoning Commission approved the rezoning of Ken Stuckey's three parcels on SR 101.

Trustee Baugher made a motion to hold a public hearing on June 25, 2018 at 8:00 p.m. for the consideration of the rezoning application for Ken Stuckey's property on SR 101. This was seconded by Trustee Distel. Mr. Moyer – yes, Mr. Distel – yes, Mr. Baugher – yes.

Trustee Baugher asks if the grass on TR 73 has been mowed sufficiently. Trustee Moyer says he has not been past it. Trustee Baugher says the lot at CR 50 and CR 17 needs mowed also. Trustee Distel will call the owner or Mike Elchert to have it mowed.

Trustee Baugher says Cory Bordner moved the dirt by the catch basin and asks if we are going to seed it or if Bordner should do it. Trustee Moyer says we should send Jim Lang out to seed it.

Trustee Distel asks if we received the \$50 in court costs from Charles Baker. Trustee Moyer says we have not received it yet but he has until Friday to pay it.

Trustee Distel says resident Brian Deats called him to report a sinkhole at Jamestown and Lelar. Trustee Moyer and Jim Lang filled it this morning. Trustee Moyer says we need to look and see if there is a line under there somewhere.

Trustee Distel reports that there are only two catch basins on Tecumseh that we still need to do. Also the one across from Phil Huss has two blocks that are starting to come in.

Regarding the volunteer firefighters association's Ford Test Drive fundraiser, Trustee Distel was verbally told that they raised \$4400.

Trustee Moyer reports that they ran a camera through the tile on TR 188. It looks like it all needs replaced. There is a chunk out of it and there are cracks in some of the tiles. The Board needs to decide if we are going to do the work or contract it out.

Regarding getting guardrail from the County Engineer's office, we need 300 ft. for TR 73 and 48 ft. for TR 130. We also need four ends. We will wait and do TR 155 at a later date.
