

Clinton Township Board of Trustees – Regular Meeting  
September 4, 2018 – 7:00 p.m.

All Board members answered roll call – Trustee Dennis Moyer, Trustee James Distel, Trustee Dennis Baugher, and Fiscal Officer Jennifer Bates.

Guests: Fred Bishop, Eric Bishop, Frank Laney, Diana Warnement, Phyllis Watts, and Dennis Kingseed.

The minutes of the meeting held August 20, 2018 were read and approved.

Correspondence: OSS Solid Waste District – memo regarding household hazardous waste collection, ODOT – memo regarding rural consultation meeting

Zoning Inspector Frank Laney reports that he has issued seven permits since the last meeting. He believes the newsletter may be helping with awareness about the zoning code.

Trustee Distel reports that the propane pre-buy with Beck is locked in at \$1.199 for summer fill and \$1.249 for pre-buy. We purchased 3,500 gallons and the price for any additional gallons needed will not exceed \$1.349.

Trustee Baugher asks if we are going to replace guardrail this fall. Trustee Moyer says we were hoping to piggyback off the county, and he heard that they re-bid their guardrail project for some reason. He will check and see if the project has been awarded.

Trustee Moyer reports that Bob Wisebaker received permits to fill in the ditch at Autumnwood and would like us to get the tile. Trustee Moyer will call Ron Schank.

Jason Nutter called regarding the water problems on TR 122. Trustee Moyer called Dave Kinn who would like to meet with the Board to discuss options before he finalizes the plans.

Trustee Moyer reports that Winfield Dr. has been paved. He also says we need to work on the newsletter.
